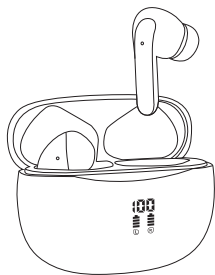

Power On: When the earbuds are in the case, open the case to power on.

Power Off/Earbuds Charging: When the case has power, put the earbuds into the case and close it, the earbuds will power off and start charging automatically.

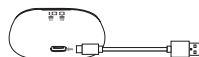
Auto Power Off: The earbuds will power off automatically if not paired in 3 minutes.

Earbuds battery low reminder: There will be an audio prompt every 1 minute.

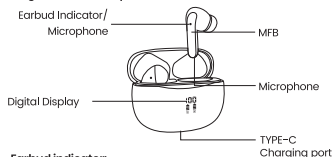
Case battery low reminder: The case battery display will show 0 or not light up after you open the case.

Case charging: Use provided Type-C cable to charge the case with DC5V power adapter only. (Do not use power supply higher than 5V, it may damage the product thus can't be charged.)



Note: Please maintain a charge at least every 3 months, if the product will not be in use for a long time, to keep the battery active and prolong the life.

Earbud indicator:

Waiting for pairing: Flash red and blue

Paired: Flash blue

Charging finished: Go off

Charging: Stay red

Pairing:

Open the cover of the earphones charging compartment, go to your device's Bluetooth settings, then find **Miccell BH32 ANC** to connect.

Operation:

① Answer the phone / Pause / Play: click the left or right earphone.

② Previous/Next track: double-click the left earphone to enter the previous track;

double-click the right earphone to enter the next track.

③ Volume +/-: three clicks on the left earphone to lower the volume;

three clicks on the right earphone to raise the volume.

④ Call settings: double-click the left or right earphone to cancel the call

when trying to make a call; double-click the left or right earphone to reject the call; double-click the left or right earphone to hang up during the call.

⑤ Start the voice assistant: long press 3 seconds left earphone to wake up or close the voice assistant, long press 3 seconds right earphone to switch mode (noise reduction or normal mode).

FAQ:

Q1: The product cannot pair with my phone.

1. Please turn off the Bluetooth of other devices and ensure the earbuds are in pairing mode.

2. Clear the pairing history of both the earbuds and your phone. Then turn Bluetooth off and on, and try again.

Q2: The Bluetooth range or sound quality is poor.

1. Bluetooth signals can be blocked by surrounding objects, which affects audio quality. If there are no obstacles between the product and your phone, the range and sound quality will improve.

2. Keep away from other Bluetooth devices, microwaves, wireless routers, and other electronic equipment.

Q3: Why is there a delay?

There is a data transmission process from your phone to the product, so you may sometimes experience a delay.

This is common for all Bluetooth devices, and Bluetooth 5.4 has improved upon previous versions.

Q4: Why doesn't the case charge the earbuds, or why don't the earbuds power off after being placed back in the case?

1. If the case has no power, the above issues may occur. Please charge the case, and it will return to normal once powered.

2. Ensure that the left and right earbuds are placed in their correct positions and that the magnetic contacts are properly aligned.

3. If the earbuds have charging insulation stickers on the metal contacts, remove them before charging.

Q5: Why can't people hear me during calls?

Please wear both earbuds when making calls and check if the microphone is blocked by any dirt.
