

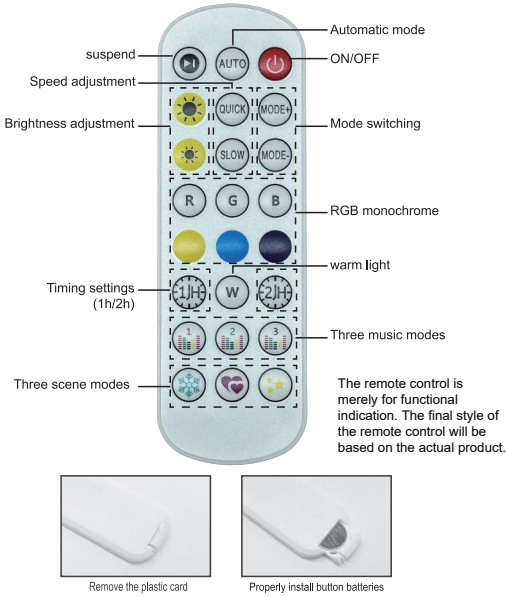

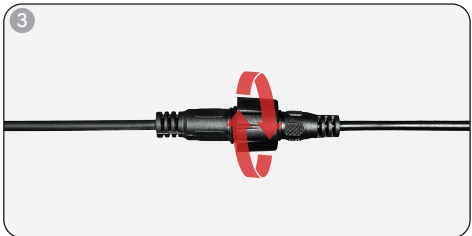
Remote Control Description

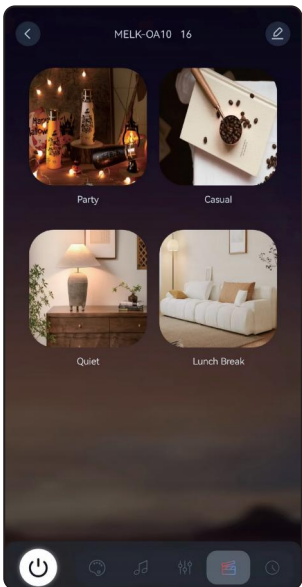

Download local music on Iphone
