Wireless charging not working	1. Power supply doesn't meet requirements. 2. Poor contact in power interface.	1. Use an adapter that meets requirements. 2. Ensure secure connection of power port.
Wireless charging slow	1. Product body temperature too high. 2. Misaligned wireless charging area.	1. Let the product cool to room temperature. 2. Place the phone in the center of the charging area for better alignment.

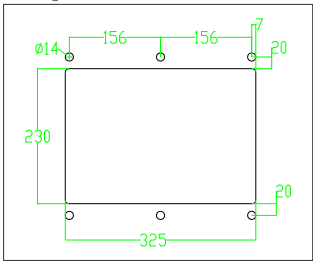

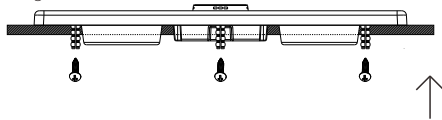


Installation
