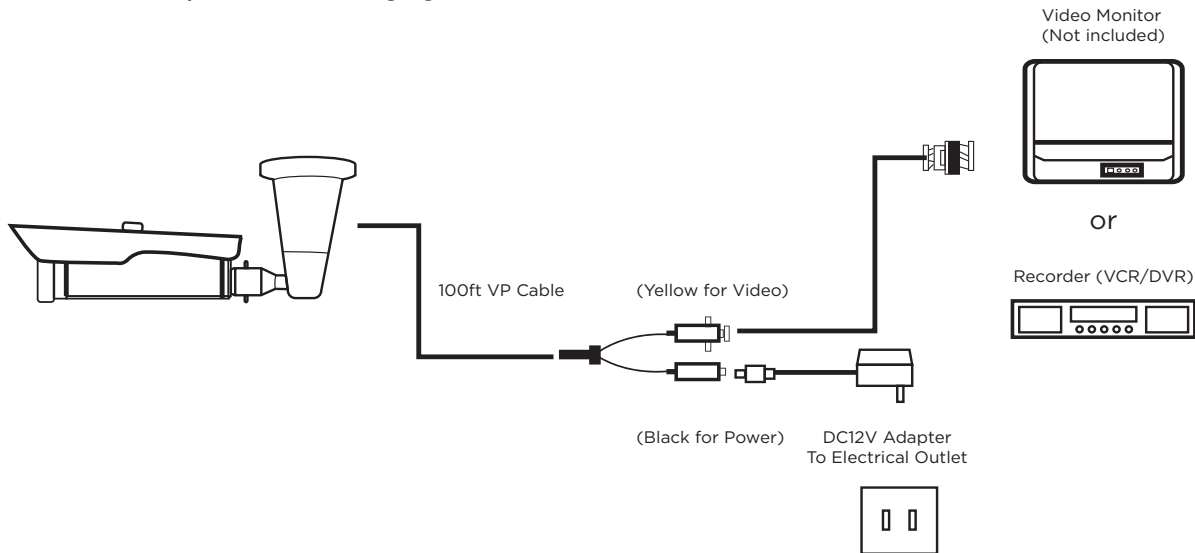

How it works:

- Connect one end of the 100ft VP cable to the camera's BNC video output (yellow) and connect the power input (black) receptacles.
- On the other end of the 100ft VP cable, connect the video output receptacle (yellow) to the video input of a monitor/TV (for direct display) or DVR/VCR (for recording).
- Connect the power receptacle (black) of the other end of the 100ft cable to one end of the included power adapter and the other end of the power adapter into an electrical outlet as illustrated below.

Note: Be sure to change the channel of the monitor output to auxiliary input channel, ie. VIDEO 1, VIDEO 2, LINE 1, LINE 2, & etc. An additional BNC (female) to RCA (male) converter is required; please check your local electric store. Position the camera to a desired location, mount it with the provided screws and adjust for the best viewing angle.



Operating Restrictions:

Conditions:

- Installation should be high in dry location, dustless and avoid exposure to direct sunlight.
- Keep product away from heat sources such as electric heater.
- Do not use the camera near aggressive chemicals.
- Do not place product near any magnetic objects.

- It might influence the normal operation of the product if used at the fringe range of normal temperature.
- Please unplug the power when not in use
- Do not disassemble the product.
- Do not shake, stricken the product, or touch the camera's lens.
