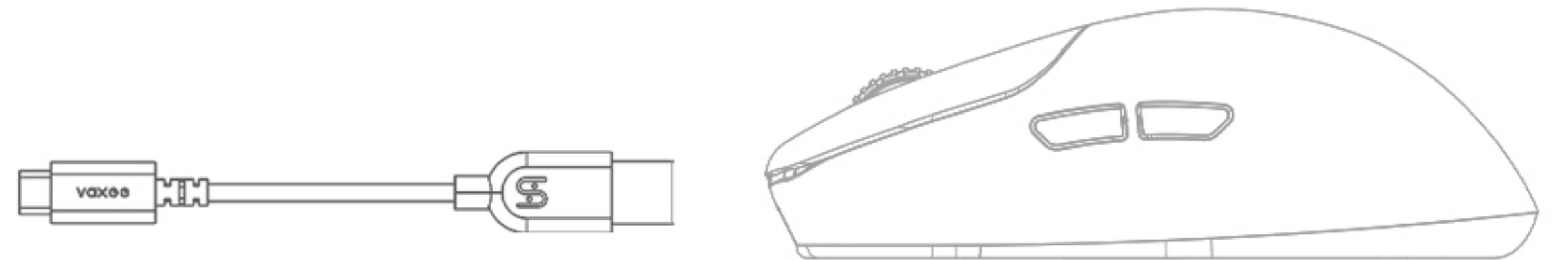

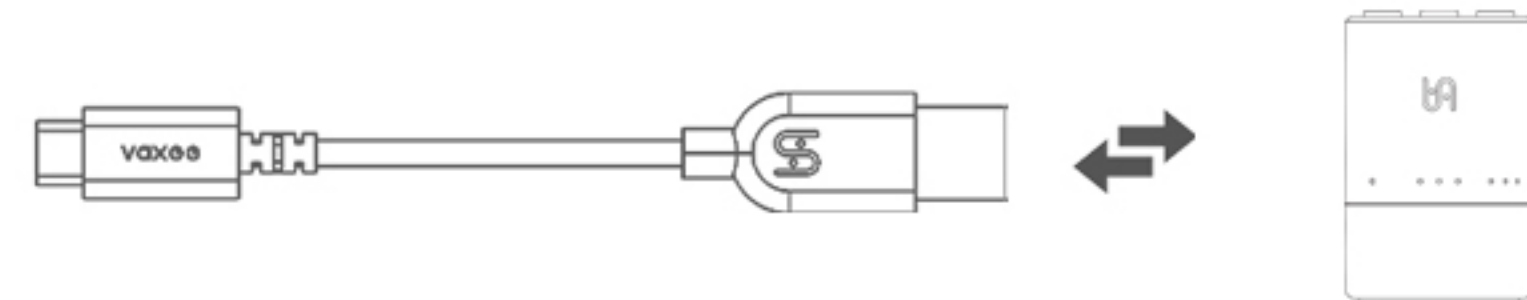
Connect the mouse to any USB port on your PC using the charging cable
