# Before You Begin...

## Caution

- Do not expose the unit to extreme temperatures (heat or cold), open flames, humid conditions, or wet conditions.
- Do not submerge in water.
- Do not open this product or attempt to repair the unit yourself should it not be working.
- Do not allow the USB ports, power jack or other inputs of the device to be exposed to dust, or water, or come into contact with any conductive materials such as liquids, metallic powders, etc.
- The amount and intensity of aroma produced will vary. Factors that affect production of aroma can include humidity, temperature, and/or air current.
- Only 100% natural essential oil should be used with this product. Oil containing chemical fragrance, spice, or other impurities, may cause malfunctions. Only use 1 - 2 drops of essential oil.
- ONLY use a compatible 5V USB adapter to power this device with the supplied USB power cable.
- It is recommended that the diffuser be covered to protect it from exposure to dust if it will not be in use for a long period of time.

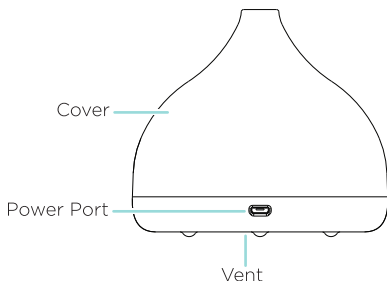

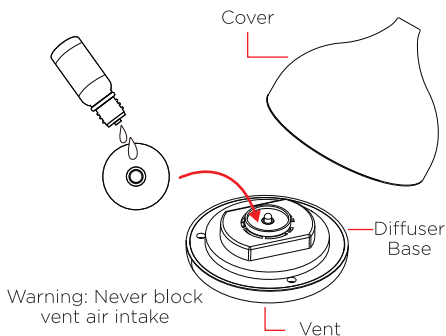
# Getting Started

## Location of Controls



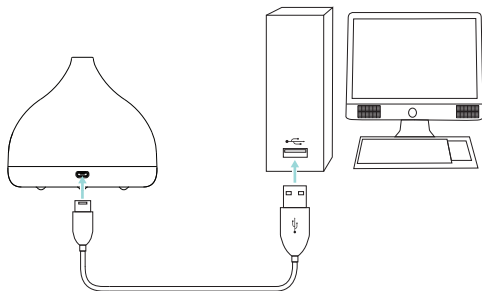
## Setting Up

Remove the cover from the top of the diffuser. Place a few drops of essential oil (***not included***) onto one of the included scent pads. Place the scent pad on the platform inside of the diffuser.



## Connecting to Power

Plug the small connector of the included USB power cable into the power port on the diffuser. Plug the large connector into a USB power port, or into a compatible **5V USB adapter** (*not included*) and plug into a wall socket.



## Using the Diffuser & Lights

1. Install a scent pad and connect to power.
2. When the diffuser is connected to power, it will automatically power on. The LED lights will turn on and cycle through different colors.
3. Place the cover back to top of the diffuser.
4. To power the diffuser off, disconnect it from power.

## Storing the Diffuser

When not using the diffuser for a long period of time, it is recommended to remove the scent pad and dry the surrounding area with a tissue.

The diffuser is best stored in an airtight box or bag (*not included*) away from heat, sunshine and moisture.

# Safety Information

## Precautions and Warnings

1. Always unplug the power cable before maintenance.
2. Essential oils can stain, in the event of a spill or leakage, please wipe away any water or oil with a soft cloth.
3. Do not let aroma blow directly onto furniture, clothing, art, or any valuable objects.
4. Keep away from direct sunlight, heat sources, air conditioners, and fans.
5. Always keep on a stable, flat surface. Do NOT place on a carpet, bed, cushion or other non-flat, non-stable surface.
6. Keep away from electronic equipment.
7. Do not use for more than 2 hours at a time.
8. Never move the product while in use.
9. Do not touch any part of the product with wet hands.
10. Keep out of reach of children and pets. Children should not be left unsupervised near this product. This unit is not to be used by children or any person(s) with reduced physical, sensory, or mental capabilities, or lack of experience and knowledge unless they have been given express supervision and instruction.
11. Keep the power cable clear of pathways, and do not forcefully pull or remove from the unit.
12. If smoke or burning smell is detected, immediately unplug the unit.
13. Each pad may be used for up to twenty days before recommended replacement.
14. Do NOT drop the essential oil directly onto the LED.
15. Please apply the essential oil to the scent pad before placing onto the diffuser platform. Do NOT apply the oil directly onto the diffuser platform.
