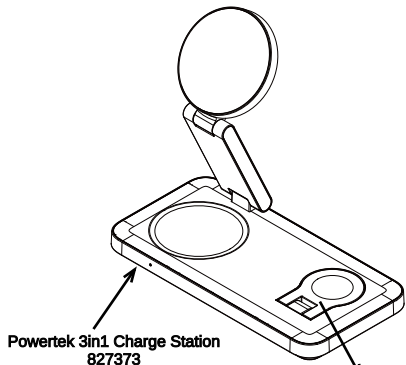

Indicator Lights

Power On

Green LED is on for 3 seconds and then turns off :◡:

Charging

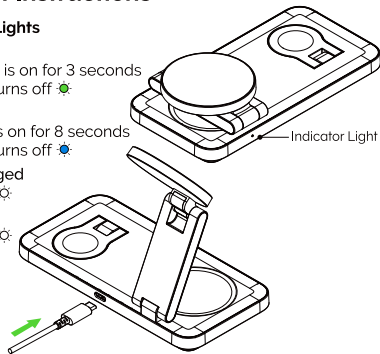
Blue LED is on for 8 seconds and then turns off :◡:

Fully Charged

Standby

Foreign Object Detection (FOD)

If a foreign object is detected, the blue LED flash once per second. Charging will resume once the object is removed.

Abnormal Temperature Protection

If the internal temperature exceeds $75^{\circ}\text{C} \pm 5^{\circ}\text{C}$, charging will automatically stop. The blue LED will flash once per second. Charging will resume once the temperature drops to $55^{\circ}\text{C} \pm 5^{\circ}\text{C}$.

Note: There is no LED indicator light for the earbuds and smartwatch pad.
