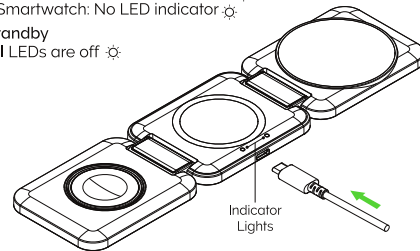
Blue LED flashes once

Foreign Object Detection (FOD)

If a foreign object is detected, the blue and green LEDs flash once per second. Charging will resume once the object is removed.

Abnormal Temperature Protection

If the internal temperature exceeds $85^{\circ}\text{C} \pm 5^{\circ}\text{C}$, charging will automatically stop. The blue and green LEDs will flash once per second. Charging will resume once the temperature drops to $55^{\circ}\text{C} \pm 5^{\circ}\text{C}$.
