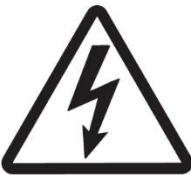

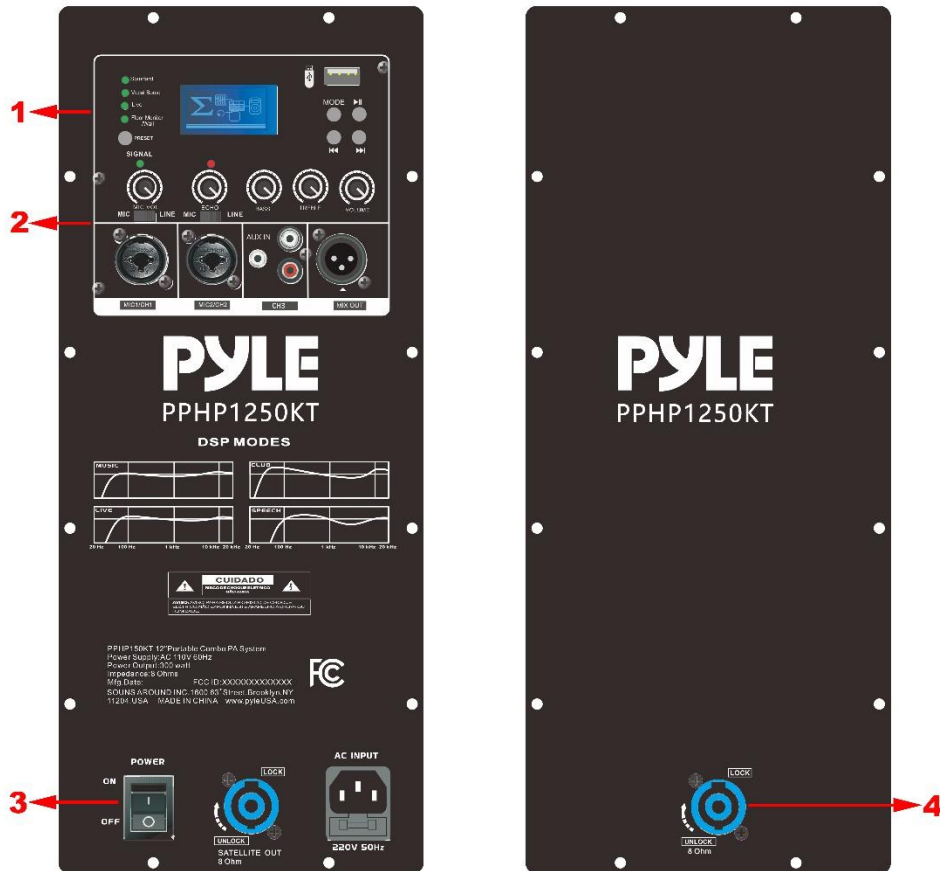

PRODUCT OVERVIEW



Section 1:

- DSP mode: Standard/Vocal Boost/Live/Floor monitor&Wall
 - PRESET: short press to select DSP mode
 - LCD display
 - USB: Insert a USB storage device to play back your stored music.
 - MODE: Short press to select BLUETOOTH /USB
- ⏮/VOL-: Short press for previous song, long press for volume down.
- ⏭/VOL+: Short press to skip to next song, long press to increase volume.
- ⏮/⏭: Short press to Play & Pause the music.

Section 2:

- MIC /LINE input volume for CH1&CH2: Rotate the knob to adjust the MIC volume to your desired level.
- MIC /LINE input switch
- MIC /LINE XLR & 6.35 Jack input
- MIC ECHO volume for CH1&CH2: Rotate the knob to adjust the MIC echo volume to your desired level.
- BASS: Rotate the knob to adjust BASS to your desired level.
- TREBLE: Rotate knob to adjust treble settings to your desired levels.
- VOLUME: Rotate knob to adjust master volume settings to your desired levels
- 3.5MM aux /RCA / input at CH3

- i. MIX XLR output

Section 3:

- a. POWER: Press to switch on /off the speaker.
- b. SPEAKON output to a passive speaker box with 4 ohm
- c. AC Power: Connect the detachable power cord to speaker and plug in to the main wall outlet
