

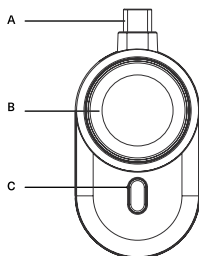

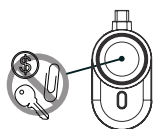

Installation Instructions

Charge Your Samsung watch Wirelessly
Connect the USB-C Input to any wall charger or USB-C Output Port, place your Samsung watch onto the wireless puck and your Samsung watch will begin to charge.

CAUTION:

Wireless Watch Charger uses inductive charging, do not place metallic objects such as coins, keys, metallic cases or metal foil on top of the charging pad.
