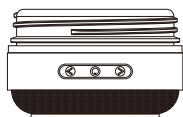


Removable Wireless Speaker

- 1 x Micro to USB-A Charging Cable

Quick Operation Guide:



- ⏻ Long Press: Turn On/Off
⏸ Short Press: Pause/ Play Music
- ⏮ Long Press: Volume Down
⏮ Short Press: Previous Track
- ⏭ Long Press: Volume Up
⏭ Short Press: Next Track

Charging:

- Using the provided charging cable, insert the Micro-USB plug into the charging port and connect the USB-A plug into a certified 5V charging device.
- LED indicator light will be solid red while speaker is charging.
- Red LED indicator light will shut off when charging is complete.

Pairing & Operation:

- Long press "ON/OFF" ⏻ to turn on the speaker. A blue light above the port will illuminate to indicate speaker is on.
- Once on, speaker will enter wireless pairing mode (flashing color lights).
- Search for "KM8426" on the wireless enabled device and connect to pair.
- Use ">" and "<" buttons for track selection and volume control.
- Switch "ON/OFF" button to OFF to turn speaker off while not in use.
