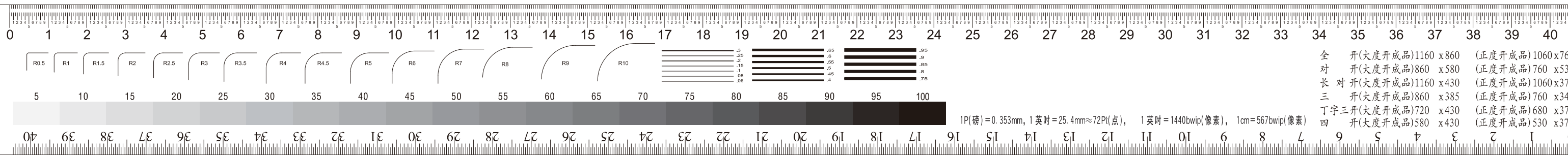

This product is a foldable magnetic wireless charger that supports smart phone charging. Please kindly read the user manual before using and keep it for future reference.

Connect to power adapter

① Connect the power adapter to socket.
② Connect one end of the Type-C power cable to the adapter and the other end to the wireless charger.
Note: This product requires an additional purchase of a P30W or higher adapter for use. Please select whether to use an adapter based on the adapter interface.

Charging mode

① Make sure the wireless charger is plugged in and in standby mode.
② Place your phone with magnetic wireless charging capability on the charging pad, the pad will automatically align and adjust the wireless charging stand to the appropriate angle.
* This product also supports charging wireless devices without magnetic charging capabilities.

连接适配器充电

① 将电源适配器插在插座上。
② Type-C电源线一端连接适配器, 另一端连接无线充电器。
注: 本产品需另外购买P30W以上的适配器使用, 请根据适配器接口选择是否使用转接头。

正确充电方式

① 确认无线充电器连接电源, 并处于待机状态。
② 将带有磁吸无线充电功能的手机放置在充电板上, 充电板会自动吸附定位, 调整无线充支架到合适的角度。
* 本产品同时支持对不带磁吸功能的无线充电设备进行充电。

FCC警告
