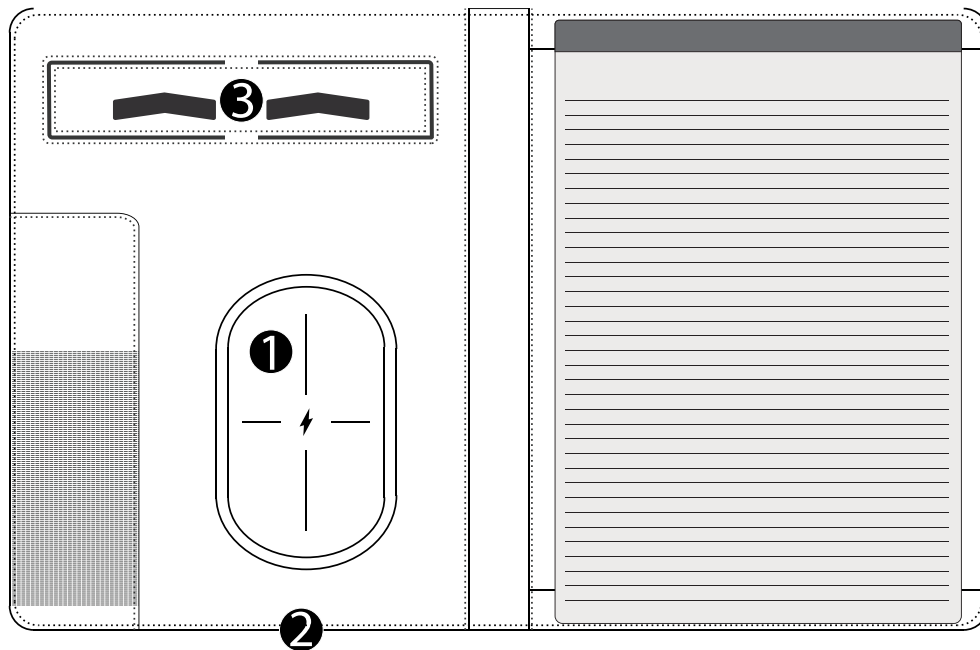

Vienna Wireless Charging Pad Writing Pad Instruction Manual

Whats Included:

- 1 x Writing Pad with Wireless Charging Pad
- 1 x Micro-USB to USB Cable



Functions:

1. Wireless charging pad surface
2. LED indicator / Micro-USB input port for the wireless charging pad
3. Phone stand

Tech Specifications:

1. USB Input: 5V/2A
2. Wireless Output: 5V/1A, 5W

Instructions:

1. Wireless Charging Mobile Phones and Other Electronic Devices:

- Ensure that your phone supports wireless charging. It will be listed in the manufacturer's specifications.
 - Connect the provided power cable to a power source and to the micro-USB port (2) on the bottom of the wireless charging pad writing pad. Once connected, the LED Indicator will turn RED.
 - Place the enabled device on the surface of the wireless charging pad (1).
 - The LED will turn BLUE to indicate that the phone is charging.
- ** If the LED indicator is flashing BLUE, an unknown object is being detected between the wireless charging pad and the phone by FOD (Foreign Object Detection), or the device is not compatible with wireless charging. The device will not begin to charge until the object is removed.

Note: In order to charge devices, use only the accessory cable or the cable included with your own device by the manufacturer.

Safety Precautions:

WARNING – When using this product, basic precautions should always be followed, including the following:

1. Read all the instructions before using the product.
2. Charge the power bank fully before initial use. The unit's full performance is achieved only after 2 or 3 completed charge and discharge cycles.
3. To reduce the risk of injury, close supervision is necessary when the product is used near children.
4. Do not expose the device to moisture.
5. Do not use the device in excess of its output rating.
6. Overload outputs above rating may result in a risk of fire or injury.
7. Do not use the device if damaged or modified.
