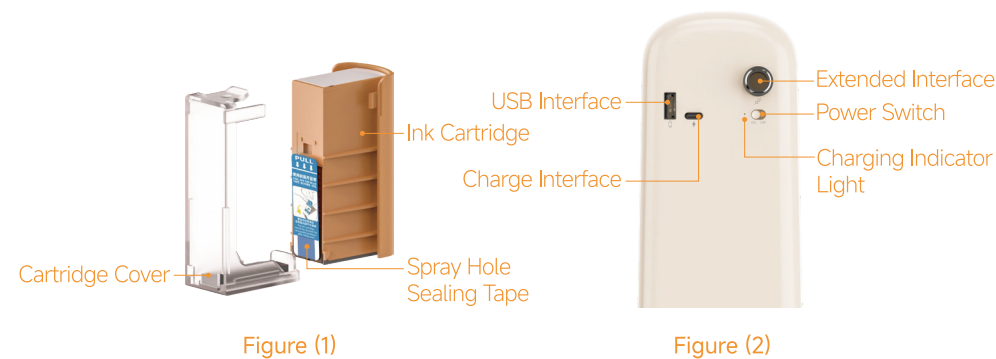

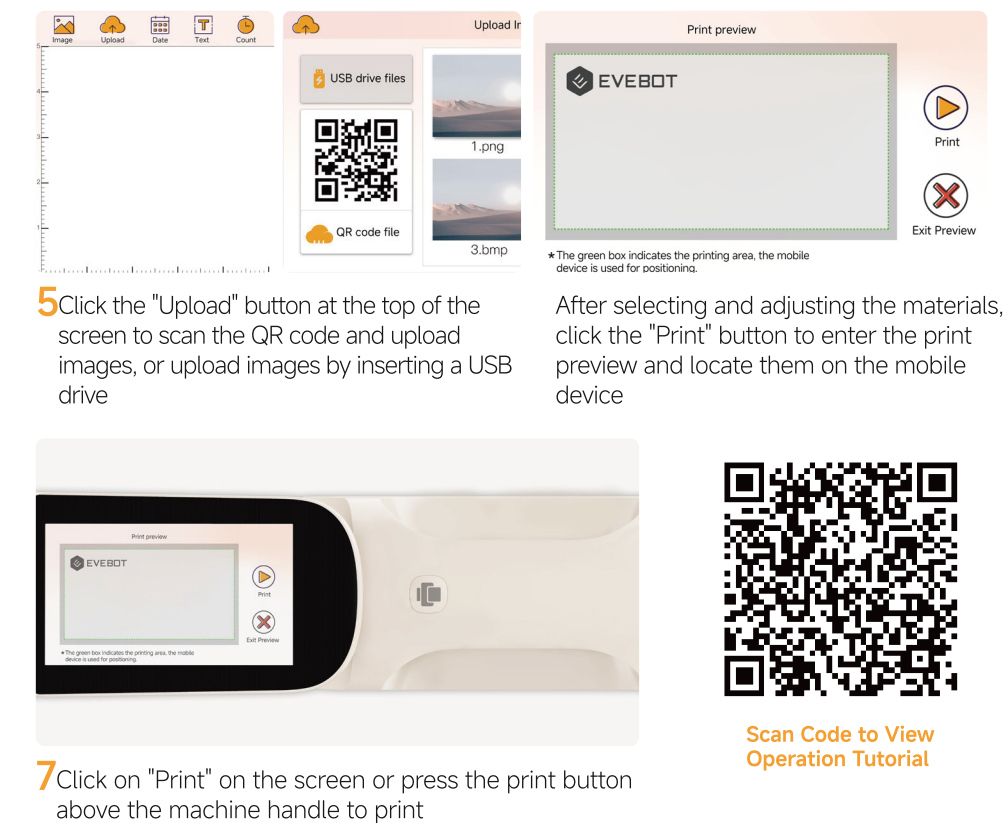

Ink Cartridge Storage and Maintenance Methods

The printhead chip of ink cartridge is very delicate and should be protected from air exposure to prevent drying out. After each use, cover the cartridge with the machine cover. If not in use for an extended period(2~3 days), it is recommended to remove the ink cartridge and seal it in the cartridge clip. In case of ink interruptions during printing, remove the ink cartridge and wrap a tissue around the printhead. Shake it for a few times, then press on tissue for a few seconds to ensure proper ink flow. Wipe the printhead clean after pressing out any excess ink before reinstalling for use.
