INSTRUCTIONS

1. Open the charging case and take out the earphones. The earphones will power on automatically.
2. Turn on the Bluetooth function on your device, search for the earphones, and tap to pair. A prompt tone will sound to indicate a successful connection.

Music

Pause/Play: Single-tap either multifunction touch control while playing.

Previous Track: Triple-tap either multifunction touch control.

Next Track: Double-tap either multifunction touch control.

Call

Answer: Single-tap either multifunction touch control when a call comes in.

Reject: Press and hold either multifunction touch control for 1.5 seconds when a call comes in.

Hang Up: Double-tap either multifunction touch control during a call.

Voice Assistant

Press and hold either multifunction touch control for 2 seconds.
