## Set Up with Alexa

1. Download the latest version of the Alexa app from the app store, then log in.
2. Plug in the power strip.
3. In the Alexa app, tap **More** from the bottom menu, then tap **Add a Device**.
4. Tap **Plug, Amazon Basics**, then select your device.
5. Follow the steps in the Alexa app to complete setup. When prompted, scan the QR code on the back of the device.

## Change Settings with Alexa

Use the Alexa app to rename a plug, add plugs to a group/room, or set up routines that automatically turn a plug on or off.

## Use the Power Strip

1. Plug in up to six devices into the AC outlets.
2. Plug in mobile phones, tablets, and other USB devices with the USB-A and USB-C ports. Both ports are always on.
3. To control with the Alexa app, tap **Devices**, the tap **Plugs** to control each outlet.
  - Note:** Use the voice control on your Amazon Alexa. (For example, "Alexa, turn on the first plug.")

## Reset to Factory Defaults

Press and hold any outlet on/off button (**B**) for about 10 seconds until the STATUS LED (**G**) alternates blinking red and green.

**Device does not turn on**

- ▶ Make sure the power strip is connected to a working power outlet.
- ▶ Make sure the outlet that your device is plugged into is turned on.

### Alexa app cannot find or connect to the device

- ▶ Make sure that your phone/tablet and the Alexa app are using the latest software version.
- ▶ Make sure your phone/tablet is within 98 ft. (30 m) of the power strip.
- ▶ Make sure that you scan the barcode in this *User Manual* or on the back of the power strip. Do not scan the barcode on packaging for setup.
- ▶ Unplug the power strip and plug it back in.
- ▶ Make sure that your phone/tablet and power strip are connected to the same 2.4GHz network. The power strip is not compatible with 5GHz networks.
- ▶ If you have a dual Wi-Fi router and both network signals have the same name, rename one and try reconnecting to the 2.4GHz network.
- ▶ Do a factory reset. See "Reset to Factory Defaults."

**WARNING** Do not plug the power strip into an extension cord, surge protector, or power strip.

## Configuration avec Alexa

1. Télécharger la dernière version de l'application Alexa dans la boutique App Store et se connecter.
2. Brancher la barre d'alimentation.
3. Dans l'application Alexa, toucher **More** (Plus) dans le menu du bas, puis toucher **Add a Device** (Ajouter un appareil).
4. Toucher **Prise (Plug), Amazon Basics**, puis sélectionner l'appareil.
5. Suivre les étapes dans l'application Alexa afin de terminer la configuration. Quand demandé, balayer le code QR à l'arrière de l'appareil.

## Changement des paramètres avec Alexa

Utiliser l'application Alexa pour renommer une prise, ajouter des prises à un groupe ou à une pièce, ou mettre en place des routines qui allument ou éteignent automatiquement une prise.

## Utilisation de la barre d'alimentation

1. Brancher jusqu'à six appareils dans les prises secteur c.a.
2. Brancher des téléphones mobiles, des tablettes et d'autres périphériques USB avec les ports USB-A et USB-C. Les deux ports sont toujours activés.
3. Pour contrôler avec l'application Alexa, toucher **Devices** (Appareils) puis sur **Plugs** (Prises) pour contrôler chaque prise.
  - Remarque** : Utiliser le contrôle vocal sur Alexa d'Amazon. (Par exemple, « Alexa, allume la première prise. »)

## Réinitialisation aux paramètres d'usine

### L'appareil ne s'allume pas

- ▶ Vérifier que la barre d'alimentation est connectée sur une prise secteur opérationnelle.

### L'application Alexa ne peut pas trouver ou se connecter à l'appareil

- ▶ Vérifier que le téléphone ou la tablette et l'application Alexa disposent de la dernière version du logiciel.
- ▶ Vérifier que le téléphone ou la tablette est dans un rayon de 30 m (98 pi) de la barre d'alimentation.
- ▶ S'assurer de balayer le code à barres dans ce *Guide de l'utilisateur* ou au dos de la barre d'alimentation. Ne pas balayer le code à barres sur l'emballage pour la configuration.
- ▶ Débrancher la barre d'alimentation, puis la rebrancher.
- ▶ Vérifier que le téléphone ou la tablette et la barre d'alimentation sont connectés sur le même réseau de 2,4 GHz. Cette barre d'alimentation n'est pas compatible avec un réseau de 5 Ghz.

## Configuración con Alexa

1. Descargue la última versión de la aplicación Alexa de la tienda de aplicaciones e inicie su sesión.
2. Conecte la barra de alimentación.
3. En la aplicación Alexa, toque **More** (más) en el menú inferior y, a continuación, toque **Add a Device** (añadir un dispositivo).
4. Pulse **Plug (enchufar), Amazon Basics** y, a continuación, seleccione su dispositivo.

## Cambie la configuración con Alexa

## Uso de la barra de alimentación

1. Conecte hasta seis dispositivos a las tomas de CA.
2. Conecte teléfonos móviles, tabletas y otros dispositivos USB con los puertos USB-A y USB-C. Ambos puertos siempre están encendidos.

### El dispositivo no se enciende

- ▶ Asegúrese de que la barra de alimentación está conectada a un tomacorriente que funcione.
- ▶ Asegúrate de que el tomacorriente en el que está enchufado el dispositivo está encendido.

### La aplicación Alexa no encuentra el dispositivo ni se conecta a él.

- ▶ Asegúrese de que su teléfono/tableta y la aplicación Alexa utilizan la última versión de software.
