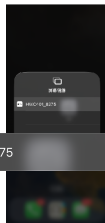
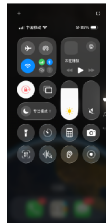

Multi touch online steps:

- Step 1:**
Turn on the Bluetooth function of your phone to connect [HWC401 XXXX](#)
- Step 2:** **iPhone Search Enter password 1234 to connect [HWC401 XXXX](#)**
(Open Phone Settings → Accessibility → Turn on Zoom → When zooming in, use three fingers to lightly tap the screen twice to restore normal operation)
- Step 2:** **Android phones start connecting from the third step**

How to set up iOS

1. Open Settings > Accessibility > Zoom > Turn on the Zoom switch.

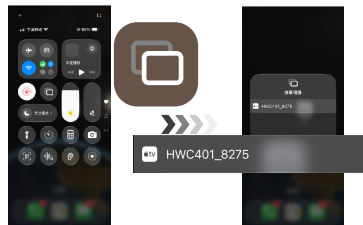


2. Double-tap anywhere on the screen with three fingers to close the zoom window.



Step 3:

Pull down from the top of the phone screen to the control center and find the wireless screen projection (Turn on Bluetooth), enable the screen mirroring function on the phone Search for device [HWC401 XXXX](#) and connect it
