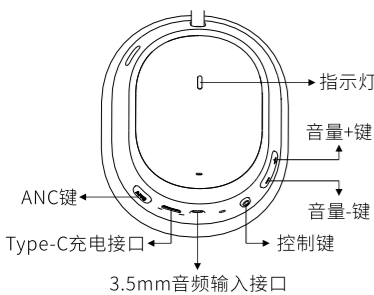

一拖二功能

EH13连接上一台设备后, 断开蓝牙, 进入配对状态; 在第二台设备上手动搜索“FiiO EH13”连接, 连接成功后, 再连接第一台设备的蓝牙。

- 长时间高音量使用耳机听音可能会影响听力。
- 充电时必须选择正规厂家生产的充电线和适配器。

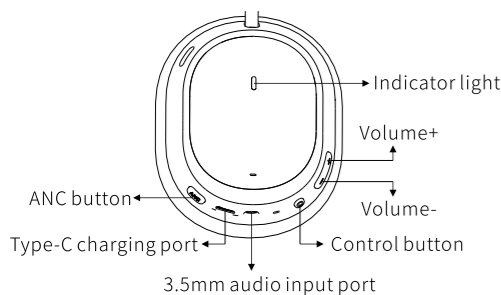

Headphone charging

Insert a USB A to Type-C cable into the Type-C port of the headphones, and connect the other cable end to an appropriate power source.

Dual-device connection (Multipoint)

After the EH13 is connected to the first device, disconnect Bluetooth to enter pairing mode; on the second device, manually search for “FiiO EH13” and connect. Once connected, reconnect the Bluetooth of the first device.

Note: For more features and OTA upgrades, please download the FiiO Control app from the app store.

1. Listening at high volumes for extended periods may affect your hearing.
